Sub.: Election to the Senate of University Teachers
Under Section 28(2)(s) of the Maharashtra Public
Universities Act, 2016:
Preparation of Electoral Roll thereof.

Mesdames/Gentlemen,

I am to invite your kind attention to Section 62 of the Maharashtra Public Universities Act, 2016 regarding the term of office of members of authorities of the University which provides that the term of every authority constituted under this Act shall commence on the 1st September and shall be of five years from the said date and the term of members of every authority shall expire on the expiry of the said period of five years irrespective of the date on which a member has entered upon his office. The process of election, nomination and co-option shall be commenced at least three months before expiry of the term of the authority and shall be completed not later that 30th November in that year.

I am to invite your kind attention to Section 28 of the Maharashtra Public Universities Act, 2016 regarding the Senate. Section 28(1) of the Act provides that the Senate shall be the principal authority for all financial estimate and budgetary appropriations and for providing social feedback to the University on current and future academic programmes. Section 28(2) of the Act, provides for composition of the Senate whereas Section 28(2) (s) of the Act, provides for election to the Senate from university teachers.

The Government of Maharashtra Order No. संकीर्ण-२०१६/प्र.क.३४७/विशि-३ dated 18th May, 2017 has introduced new statute in the Maharashtra Public Universities Act, 2016. Further, the Government of Maharashtra Gazette dated 29th April, 2017, has introduced the eligibility conditions for getting elected as member of various authorities/bodies.

The University is therefore inviting all the approved university teachers to register themselves with the University. The university teachers can enroll themselves for appearance of their name on the Electoral Roll is as per the procedure laid down by the University. The registration shall start from the date of this notification i.e. Monday, 5th June, 2017 and ends on 4th July, 2017 by 4 pm. The procedure for enrolment of University Teachers is described herein below:

1) Online Registration:-

An individual University Teacher shall fill in an online application "FORM" on University website- www.mu.ac.in (Election Portal). The notification and instructions are available on this University website. The University Teacher shall be completely responsible for any mistake made in the Registration Form. The University do not take any responsibility in case of wrong information submitted by the Applicant.

2) Submission of filled in FORM by the respective University Teacher :-

Every University Teacher shall take printout of 'Filled-in online form', duly signed by themselves alongwith approval letter issued by the University, shall submit to the respective Directors of University Institutions /Head of University Department /Principal of Conducted Colleges.

3) Responsibility of Director / HOD / Principal :-

- i) Each <u>Director/HOD/Principal</u> shall be duly bound to inform every University teacher in his Institution / Department / College about Online Registration process for the preparation of Electoral Roll of University Teachers.
- ii) Teachers can fill in online application form and submit the printout with all necessary documents to their respective Director/ HOD/ Principal.
- iii) The Director/HOD/Principal of University Institutions/University Department/Conducted Colleges shall submit duly filled-in forms of university teachers, duly verified by them along with their Seal and Signature, to the University at the Deputy Registrar, Election Section, Room No. 110, First Floor, University Main Building, Fort, Mumbai 400 032 on or **4th July, 2017 by 4 p.m.**.

I am to inform you that the Senate will be constituted under Section 28(2) of the Maharashtra Public Universities Act, and process of election will commence with the preparation and publication of the Electoral Roll for the said election. Definition of "university teachers" as defined under clause (68) of Section 2 of the Maharashtra Public Universities Act, 2016, is reproduced below for ease of reference:-

- (19) Collegium of Teachers means an electoral college consisting of fulltime teachers from University Departments, University Institutions, and Conducted Colleges appointed by University who shall elect from amongst themselves as members to the different authorities.
- (68) University Teacher means a fulltime teacher appointed by the university. Reading together section 19 and 68 above of chapter 1 of Maharashtra Public University Act 2016, it implies that University Teacher means; the person who is appointed by duly followed selection procedure and not the CHB teacher or teachers appointed by local selection.
